## **ANNOUNCEMENTS FROM THE ENVIRONMENTAL SANITATION COMMITTEE: REFUSE MANAGEMENT, SANITATION AND PROHIBITION OF ALMS BEGGING**

The attention of the Environmental Sanitation Committee has been drawn to the unkempt and unsightly state of various refuse dump sites on campus. To this end, the Committee wishes to bring the following information to the attention of the University community that:

### **REFUSE**

- i) Each building (residential, office, worship centres, commercial ventures) on campus must **procure a refuse bin and place such at strategic location for the attention of refuse collectors**. Sample of recommended refuse bin can be seen at the Physical Planning Unit or the Trenchard Hall Court Yard.
- ii) Members of the University community should **DESIST** from emptying refuse in locally created dump sites near their homes, in gutters, by the roadside etc, but must **BUY** and **USE** refuse bins in their individual residences/offices etc.
- iii) **NON-RESIDENT STAFF** who are in the habit of **IMPORTING REFUSE** from their homes in town into the campus should henceforth **DESIST FROM THIS UNCIVIL PRACTICE** as the Campus Security Service has been mandated to arrest (irrespective of status) and report such case(s) for transfer to the appropriate Disciplinary Committee.

Please note that the old **REFUSE DUMP SITES** are hereby scrapped. They are no longer **MEANT FOR DISPOSAL OF REFUSE FROM RESIDENCES/OFFICES, WORSHIP CENTRES AND COMMERCIAL VENTURES** etc. Please, procure a refuse bin for your building/block/worship centres etc and place such at a strategic location for evacuation by the refuse collectors.

### **RESIDENTIAL QUARTERS**

Occupants of University residential quarters are responsible for keeping their premises clean, cutting the grass, maintaining well trimmed lawns, hedges and ornamental plants.

***Kindly note that henceforth, the University Management would be decisive in dealing with any defaulter.***

### **ALMS BEGGING**

Begging (under any guise) is prohibited on the University campus. Members of the University community should report immediately to the Campus Security Service

whenever anyone approaches their home or office to beg for alms or other unwarranted assistance. There is a huge security risk in entertaining strangers who appear to be beggars. The Campus Security Service has been mandated to discourage this habit at worship centres during special programmes and especially on Fridays and Sundays. Any beggar caught will be handed over to the law enforcement agencies.

Members of the University community are enjoined to be conscious of the need to attain and maintain clean environment. There must be a collective effort to ensure Environmental Sanitation on campus and to report defaulters to the appropriate University organ.
